

EXHIBITORS: FOLLOW THESE EASY STEPS!!

- > Shipping is **not** an automatic process. **You** must complete the required paperwork and make the telephone calls to your third-party carrier to ensure the return of your packages.
- > Exhibits officially close August 10, 2023 at 1:00pm.
- Exhibitors are required to pack and secure the packages for outbound shipment. The packages **must** have labels affixed to your packages. You may leave your packages in your booth area.
- ➤ If Wisconsin Expo, Inc. finds any **UNLABELED** packages left in any booth area, these **UNLABELED** packages may be disposed of at show site if there is no indication of what to do with them.
- > A completed Bill of Lading is also required for **all** outbound shipments. The Bill of Lading contains the details of the shipment being sent out. These important details give the carrier the necessary information to ship your freight/packages correctly.
- You must sign the Bill of Lading **prior** to leaving your booth/show, but **NOT** before your packages are **PROPERLY LABELED.** The Bill of Lading can be handed to one of our onsite representatives who is dismantling the show or left in the booth with the package(s).
- Abandoned packages not removed by exhibitors or picked up by third-party carriers will be taken to the Wisconsin Expo, Inc. warehouse at the exhibitor's expense. If your package comes back to our warehouse, we will alert you by phone call or email.
- > NOTE: If the packages are going to multiple destinations, complete a Bill of Lading for each destination.




